



Pool Opening Contract 2024

This Pool Opening Contract is entered between **OnSite Pool Service LLC** and _____ for the purpose of opening their pool for the 2024 pool season.

Every opening consists of the following:

- Pool cover removal
- Basic system setup
- Pool unplugged
- System startup
- First initial dose of chemicals
- 1 follow up visit

*The following chemicals are included with our pool opening service; Calcium Hypochlorite, pH Increaser and Total Alkalinity Increaser. Any other chemicals, including specialty chemicals, will be charged based on the swimming pool gallonage and the recommended product dose.

Follow-Up Visit: The Customer will receive one included vacuum after the initial opening process. This follow-up visit will typically occur within 24-72 hours after the pool opening. If additional visits are required to ensure the pool is ready for swimming and chemically balanced, the cost will be \$75 per visit, plus any additional chemicals needed.

Price and Deposit: The price for our pool opening service is \$550 . A 50% deposit is required before the service can be scheduled.

*Pools with additional features such as attached spas, slides, grottos, or waterfalls will incur an additional charge of \$125.

Service Date: The Customer shall choose the week in which they would like their pool to be opened. **OnSite Pool Service LLC** will contact the customer prior to arrival to let them know which day will be their scheduled opening day.

Customer Responsibilities: The Customer is responsible for ensuring the following is prepared on the day of their scheduled opening.

- a. All necessary equipment is left out or easily accessible.
- b. Gates are unlocked or code/key have been provided for easy access.
- c. Power for the filtration system is on or breakers are easily accessible.
- d. Service outlets near the pool are easily accessible for power if required.
- e. The pool is topped off with additional water if the water level is low to ensure we can run your pool.

Equipment and Service Issues: Any equipment issues or service-related issues will be charged as service calls, including the cost of parts and labor. Before any repairs are made, Service Provider will contact the Customer to discuss estimated costs for repairs valuing over \$100. Minor repairs under \$100 will be made onsite without the Customer's need for approval if materials or parts are readily available on the work vehicle. These repairs will be documented and charged upon completion.

Payment: The final payment is due upon completion of the included follow-up visit.

Additional Charges: Failure to meet the customer responsibilities outlined in may result in additional charges due to the need for a return visit or reschedule.
